## **VIRTUAL ANNUAL MEETING TO BE HELD AUGUST 13**

Central Wisconsin Electric Cooperative will be hosting a virtual annual meeting on Thursday, Aug. 13, 2020, at 6 p.m.

When the original annual meeting that was scheduled for April 21 was postponed due to the COVID-19 pandemic it was hoped that it could be rescheduled for a future date and still be held in-person. Due to the continued impact of COVID-19, the CWEC Board of Directors opted to pursue hosting a virtual meeting for the safety of our members and employees.

You should have received the director election mailing from CWEC, which contained information about the virtual annual meeting, including how to register for the meeting and how to log in. That information is also listed below.

The annual meeting is open to CWEC members only. Members can now register online at www.cwecoop. com/annual-meeting-2020 to receive their invitation to the meeting. Your billing account number is required when you register.

#### **BOARD OF DIRECTORS ELECTION**

Three CWEC Board of Directors elections were scheduled to take place when the original annual meeting was scheduled in April. Because we were unable to host that meeting, the current directors have continued to fill those roles until the annual meeting could be rescheduled and held. The results for the three elections will be announced at the

virtual annual meeting on August 13.

Election ballots were mailed with the same mailing that contained the information card about the virtual annual meeting. All ballots must be delivered to CliftonLarsonAllen LLP in Marshfield by the close of business on Wednesday, August 12, 2020.

### **BOARD MEETING SUMMARY**

A regular meeting of the Board of Directors of Central Wisconsin Electric Cooperative was held via teleconference call at 8:05 a.m. on May 28, 2020. The following is a summary of the meeting activities. The agenda, minutes of the April 30, 2020 meeting, new and terminated memberships, and the monthly safety and compliance report were approved.

#### Action Items

- Monthly Financial Statements and Reports were approved. Finance Committee reviewed checks written and the board and CEO expenses.
- The Governance Committee approved changes presented by the Governance Committee to Board Policy 101 concerning eligibility of relatives of a director to serve on the board.
- c. Jim Halvorsen of CliftonLarsonAllen, LLP presented the results of the 2019 Financial Audit via teleconference call.
- d. Following a brief discussion on the previous three biennial results of the board's self-evaluations from 2014, 2016, and 2018, the board agreed to proceed with the 2020 self-evaluation which will be sent out in June.
- e. The board approved holding the Member Appreciation Breakfast on Saturday,

- October 31, 2020, pending the safety of employees and members due to COVID-19.
- f. Discussion was held regarding when and how to hold the 2020 Annual Meeting. Additional information was requested and will be presented for further review at the June meeting.

Operations and Engineering — Mr. Kurtzweil reported the crews are working on new connects. PUSH Inc. has finished pole replacements found during last year's inspection. Linda Power of River Valley Architects will be planning an onsite visit and provide us with an estimate for securing the front counter/lobby area. Mr. Kurtzweil is working with PGA Plumbing, Heating and Cooling on our heating and cooling issues.

Accounting and Finance — Financial reports were reviewed. Ms. Shower reported due to COVID-19, we did not do disconnects in April and May. 538 letters were sent out to the past-due members asking them to contact us to discuss payment arrangements.

Member Services — Ms. Mazemke reported her department has been posting social media updates with changes and notifications. The Economic Emergency Relief Loan Program will be ending June 1. The Executive Committee of the board will be reviewing and approving those loan applications.





### Annual Meeting Minutes • April 23, 2019

Vice Chairman Tom Smith welcomed the membership to the 81st Annual Meeting of Central Wisconsin Electric Cooperative at 6:00 p.m.

Vice Chairman Smith recognized all veterans and thanked them for their service before leading the membership in the reciting of the Pledge of Allegiance.

Vice President of Operations Kevin Kurtzweil gave a safety message to the membership. Board Chairman Anthony Buss, Jr. introduced the directors and special guests in attendance.

The 81st Annual Meeting of Central Wisconsin Electric Cooperative was called to order by Chairman Buss. Elaine Eckendorf, Secretary/Treasurer of the Cooperative, kept the minutes thereof.

Director Eckendorf announced that in accordance with the Cooperative bylaws, sufficient members had registered to constitute a quorum. Official registration counts totaled 189 members and 70 guests for a total of 259 in attendance. Motion was made and seconded to dispense with the reading of the Official Notice of Meeting and Proof of Mailing. Motion carried. Motion was made and seconded to close balloting for the director election. Motion carried. Motion was made and seconded to dispense with the reading of the 2018 Annual Meeting Minutes and approve as presented in the April 2019 *Wisconsin Energy Cooperative News* magazine. Motion carried.

Cooperative Attorney Drew Parrish of the law firm of Wheeler, Van Sickle and Anderson reported on the proposed bylaw amendments. Those amendments included a title change to "Amended and Restated" and changes to Article III - Meetings of Members - Section 5, Article IV – Directors – Sections 2, 3, 4, 5 and 7. Motion was made and seconded to approve said Bylaw amendments as proposed. Motion carried. Attorney Parrish then explained that Article I – Membership – Sections 1, 2, 4 and 7 of the Bylaws was amended and approved by the board at their December board meeting. Copies of proposed bylaw amendments and Board approved bylaw amendments were provided to the members present.

Vice President of Operations Kevin Kurtzweil, Manager of Member Relations Brenda Mazemke, and Vice President of Accounting and Finance Lila Shower each gave their department reports for the year 2018.

Chairman Buss noted that 2018 was another successful year for the Cooperative, allowing a return of investments back to the members in the form of capital credits. Commitment to Community is a cooperative principle that we are very proud of. In addition to CoBank Sharing Success donations, the Cooperative participates in Toys for Tots, scholarships, donations to local charitable organizations and economic development loans. Safety is the highest priority of CWEC. Employees have worked over 350,000 hours without a lost-time accident and driven over 800,000 miles without a vehicle accident. CWEC was recently honored by the Wisconsin Safety Council as one of 13 recipients statewide to receive a corporate safety award.

David Wozniak of the accounting firm of CliftonLarsonAllen gave the results of the 2018 Director Election as follows:

#### **Our Mission**

We are your trusted energy partner and provider of valued community support.



There are many things that Central Wisconsin Electric Cooperative does to ensure that electricity keeps flowing to all our members. One of those is vegetation management. You may be asking yourself, what is vegetation management and what does it have to do with electricity?

The vegetation management program that CWEC follows is the process of clearing trees and vegetation to keep our rights-of-way clear. We use many pieces of equipment to accomplish this goal, including chainsaws, bucket trucks, tree climbers, and mowers.

Now you may be asking yourself, what are rights-of-way? A right-of-way is a corridor or pathway of land that CWEC's electric lines follow. The right-of-way provides CWEC an operation safety zone between wires and trees, buildings, or other objects. When these corridors are kept clear they also provide safe access for line crews to maintain, repair, or improve the power lines and poles. The CWEC vegetation management program helps keep the rights-of-way clear of undesirable vegetation.

It is important to keep undesirable vegetation out of rights-of-way because it helps maintain electricity reliability, and shortens the length of outages when storms roll through the area. A successful vegetation program also helps provide

public safety, as well as safety to all the workers who need to work on the utility lines.

The tree contractors who work to accomplish the goals of CWEC's vegetation management program are qualified and insured to do this work. CWEC is in the second year of contracting with Zielies, which is located in Bruce, Wisconsin. We are also currently on a scheduled six-year substation/circuit vegetation management program.

In 2019, a total of 150 miles of brushing pertaining to four substations/circuits was completed. In 2020, 157 miles of brushing pertaining to four different substations/circuits is scheduled to be completed.

In addition to clearing rights-of-way of vegetation, CWEC may integrate selective herbicide application to rights-of-way. The third year after cutting and trimming is when a herbicide application might take place. Not all areas that are cut are appropriate for herbicide application. We use herbicides to control the amount of brush that sprouts from hardwood species that were cut. Once a single stem has been cut, it may sprout into as many as 15 new stems that grow rapidly. The selective herbicide application targets only these species.

In 2019, herbicide spraying took place in the areas of four CWEC substations/circuits. Four additional areas pertaining to CWEC substations/circuits are scheduled for herbicide application in 2020.

While we work hard to manage the vegetation in rights-of-ways, CWEC also understands that there may be trees outside the 30-foot right-of-way area that pose a threat to power lines. The right-of-way for utility poles with crossarms is 20 feet on either side of the line. Using a Hazard Tree Program, CWEC identifies trees outside the right-of-way corridor (15 feet on either side of the line) and removes them if they are deemed a threat to fall on power lines.

By taking these proactive steps to remove vegetation near utility lines, it increases our ability to keep the lights on before a storm rolls through the area.

"CWEC is obligated to all our members to maintain safe and reliable electric service," said Kevin Kurtzweil, vice president of operations at CWEC. "Vegetation management is an important component of that work."







Properly cleared rights-of-way provide plenty of space for CWEC vehicles, employees, and contractors to access the lines.

## CONGRATULATIONS TO OUR 2020 SCHOLARSHIP RECIPIENTS

With donations from the Central Wisconsin Electric Cooperative's members through the Operation Round Up program, \$12,350 has been awarded to students pursuing a post-high school education. Of that total, \$10,150 has been approved by the Operation Round Up Trust Board, to be awarded to first-time scholarship applicants who will be attending a technical college or a university. The 29 students who will be receiving a \$350 scholarship are listed below.

CWEC also awarded \$100 Operation Round-Up Scholarships to 23 repeat scholarship applicants. We thank our members who participated in the Operation Round Up program; more than \$531,508 of Operation Round Up funds have been paid to worthwhile charitable and educational purposes.
