
have to serve as director. The proposed language can be found in this magazine edition and I ask everyone to read through these changes carefully. If you have questions or concerns about this revision, please contact our office.

CWEC 79th Annual Meeting Saturday, April 8

Join Central Wisconsin Electric Cooperative on Saturday, April 8, 2017, for our 79th Annual Meeting. The meeting will be held at the Wittenberg-Birnamwood High School Auditorium in Wittenberg.

Registration for the meeting begins at 9 a.m., with members having an opportunity to socialize over coffee and rolls and view various displays.

Music by the Bowler High School Band will be from 10–10:30 a.m. in the school auditorium. President & CEO Mike Wade and Board Chairman Anthony Buss, Jr. will keynote the meeting's business session, which begins at 10:30 a.m. During the business session, members will have the opportunity to hear how their co-op is faring financially, learn details about various services offered by their member-owned power supplier, and receive updates on state and federal regulatory issues of importance to electric co-ops. An election of three board positions will be held. Members in attendance will also vote on a bylaw amendment to Article IV, section 5.

Bylaw change to be voted on at annual meeting

One item of business at the Central Wisconsin Electric Cooperative annual meeting to be held on Saturday, April 8, 2017, at the Wittenberg-Birnamwood High School Auditorium is a proposed bylaw change. The change redefines the qualifications for eligibility to serve on the Board of Directors. The current language is outdated and does not adequately answer many of the questions that are often raised regarding director eligibility. In an attempt to better define director qualifications, we are proposing modifying only this area of the bylaws.

Your Board of Directors and legal counsel have reviewed the bylaw amendment and are recommending its approval. Bylaw changes affecting the election of the Board of Directors must be approved by the membership. A vote on this bylaw amendment will be taken at the annual meeting on Saturday, April 8, 2017. If you have questions regarding the proposal, please feel free to contact our office.

The current language under Article IV, Directors, Section 5 is as follows:

SECTION 5. Qualifications. No person shall be eligible to become or remain a board member of the Cooperative who:

- A. is not a member and bona fide resident in the area served or to be served by the Cooperative, a bona fide consumer of electric service supplied by the Cooperative and a resident of the district from which elected; or
- B. is in any way employed by or financially interested in a competing enterprise or a business selling electric

energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative; or

C. is employed by the Cooperative within three (3) years prior to the date of taking office.

Following a due process hearing as provided in Section 6 of these Bylaws, upon establishment of the fact that a board member is holding the office in violation of any of the foregoing provisions, the board shall remove such board member from office.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the board.

Proposed substitute language for Article IV, Directors, Section 5

SECTION 5. Qualifications. To become and remain a Director, a person must comply with the following qualifications:

- A. be an individual who is a member served by the Cooperative at his or her residence, who is a bona fide resident of the district which the individual is to represent, and who has been a bona fide resident of that district for at least the one year immediately before his or her nomination;
- B. have the capacity to enter into legally binding contracts;
- C. while a Director and during the one year immediately before becoming a Director, not be, be employed by, control, own more than ten percent of, serve as a director or officer of, or receive more than ten percent of annual gross income from
 - a. an individual or entity that competes with the Cooperative, a Cooperative Subsidiary or a Cooperative Affiliate,
 - b. an individual or entity that provides a good or service similar to a good or service provided by the Cooperative, a Cooperative Subsidiary or a Cooperative Affiliate, within the same geographic area as the Cooperative, Cooperative Subsidiary or Cooperative Affiliate, or
 - c. an individual or entity that directly or indirectly advances the individual or entity's pecuniary interest by engaging in business dealings with the Cooperative, a Cooperative Subsidiary or a Cooperative Affiliate,

if such interest or relationship would likely impair the individual's ability to serve the best interest of the Cooperative. Nothing in this provision shall be construed to disqualify any member from serving as a director who provides electric energy by means of distributed generation facilities that are interconnected with Cooperative facilities.

D. while a Director and during the three years immediately before becoming a Director, not be an employee of the Cooperative, a Cooperative Subsidiary or a Cooperative Affiliate;

- E. while a Director, not be a relative of a Director or Employee of the Cooperative or of a Cooperative Subsidiary or Cooperative Affiliate except as may be reasonably authorized by the Board as set forth in a policy or policies adopted by the Board;
- F. Not have been previously removed as a Director by the Board or the members in accordance with these Bylaws, or shall not have resigned as a Director while a proceeding to remove him or her was pending;
- G. while a Director not be, and at any time during the three years immediately before becoming a Director, not have been a party in any stage of mediation, arbitration, lawsuit, or other legal action against or by the Cooperative or a Cooperative Subsidiary;
- H. while a Director and during the five years immediately before becoming a Director, not be convicted of, or plead guilty to, a felony or first degree misdemeanor;
- I. except as otherwise provided by the Board for good cause, attend at least two-thirds of all Board Meetings during each year of the Director's term of office; and
- J. any other reasonable qualifications set forth in a policy or policies adopted by the Board.

Nothing in this section shall be construed to preclude any member from serving as a director because such member is also a member or a director of any other cooperative from which this Cooperative purchases or may purchase electric energy, supplies or services, or which is engaged in selling electrical or plumbing appliances, fixtures, or supplies to the members of this Cooperative.

Following a due process hearing as provided in Section 6 of this Article, if the Board determines that a Director is in violation of any of the foregoing provisions, the Board shall remove such Director from office.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the Board.
