## CWEC BEGINS COST-OF-SERVICE STUDY

Have you ever wondered how the rates you pay for electric service are established?

The revenue derived from the rates paid by the members for electric service funds the operation of the electric cooperative.

It is the responsibility of the board of directors and management to examine rates periodically to be sure that they are just and reasonable and will allow the cooperative to fulfill its obligations to the members and the cooperative's lenders. At this time, Central Wisconsin Electric Co-op is beginning the process of a cost-of-service study to accomplish this. Over the next few months, we will explain the different parts of the rate study process.

Rate studies are complicated. In a sense, they are an attempt to predict the future, or at least the answers to a few questions. What revenue will be required to fund the operation of the cooperative for the foreseeable future, and what is the fairest way to collect that revenue through rates? What external factors will affect the cooperative's financial picture? What will the weather be like in the coming years?

While we may never accurately predict the weather in the future, an attempt can be made to predict the other variables that affect rates. CWEC has retained the services of Power System Engineering to assist us with our cost-of-service and rate study.

This study has several stages. First, we will use existing data to determine what revenue is required to operate the cooperative in the future. Next, the cost-of-service study is conducted to assign the costs to provide electric service to member classes using traditional ratemaking principles. Then rates will be designed to meet the cost recovery obligations, to cover the revenue fairly from each member class, and to meet any other strategy or goals identified by the board in the rate study process.

When the rate study is completed, it will be reviewed by the board in detail. You show confidence in your board of directors when you cast a vote for their election to the position. The board takes its responsibility to set fair rates very seriously. After all, they are members of the cooperative and pay the same rates.

We will also share the rate study information with and garner input from a Member Advisory Group. As we move through the process we will hold member forums throughout our service area to keep you informed.

"Budget" is not a four-letter word, but it feels like one sometimes. For several months, staff and the board of directors have been meticulously laying out goals and developing a budget for the activities of 2016. In the words of former Secretary of the Treasury Jack Lew, "the budget is not just a collection of numbers, but an expression of our values and aspirations."

As is always the case, we are not able to do all that we would like to in the coming year, but we have planned and prioritized to do as much as possible. The board approved our 2016 budget at their December meeting, and here are some of the projects we will be working on.

We have budgeted \$2.5 million for our 2016 construction work plan. Upgrading and maintaining our electric system as well as constructing new service to our members is the heart of what we do as an electric utility. We have over 1,430 miles of electric lines in place, and the poles and wires have a finite life. As we do each year, we have earmarked a significant budget amount to ensure these facilities are well maintained and offer our members the reliability they deserve.

Another large budget item for us is vegetation management. Thank-

fully, the cooperative has made large investments in this area in the past, so we are spending less today because we have rights-of-way that are in good condition. However, due to the fast growth of vegetation in Wisconsin, we must remain vigilant and stay true to our vegetation management rotation cycle.

We are working on several projects that involve compliance with how we take credit card payments. These are industry compliance standards that require us to take credit card payments in a secure manner so that the risk of your card being compromised is decreased. We will have more specific information about these changes in future magazine editions.

As a utility it is very important that the metering of our members' load be accurate and reliable. We will again use a company that specializes in meter testing to perform field tests to verify the accuracy of the metering on our largest loads. This has been a very beneficial program for us as we have found several problems during the previous year which required correction.

These are just some of the projects we have underway for the new year. We remain dedicated to working on programs and services that offer the best value to the membership. Together, we can meet the challenges that lay before us, and I look forward to a bright year ahead.
























## STOCKBRIDGE-MUNSEE RECEIVES **CWEC ENERGY EFFICIENT GRANT**
