2022 YEAR IN REVIEW



B efore I share my thoughts about some of the major happenings that took place at Central Wisconsin Electric Cooperative in 2022, I want to thank all of the co-op's members, volunteer member committees, employees, and board

members for the support and commitment to CWEC. The strength of any cooperative is its membership and we are fortunate to have so many members who are willing to give of their time and talent to help keep our cooperative healthy and strong.

In 2022, we welcomed Allen Zander to the CWEC Board of Directors. Allen has brought great insight to the board, and I look forward to working with him for years to come.

As a cooperative, CWEC is guided by seven principles. One of those principles is "Concern for Community." As a participating member of the CoBank "Sharing Success" charitable contribution program, CWEC makes up to three donations totaling \$1,000 each year to qualifying 501(c)3 organizations located within communities that we serve and CoBank matches our donation to these organizations, totaling \$2,000 per organization. The CWEC matching donation comes from its Federated Youth Foundation fund. The 2022 recipient organizations included: the Mattoon Fire Department, Stockbridge-Munsee Fire Department, and Rural Health Initiative.

In December the co-op conducted another successful Marine Toys for Tots campaign that helped provide toys to more than 1,000 area children. It is an honor and a privilege to be involved with the Marine Toys for Tots organization.

In keeping with the cooperative principle dealing with education, CWEC introduced a new STEAM grant program to help extend resources to area schools to support science, technology, engineering, art, and math projects and initiatives. Three area school districts—Bowler, Tigerton, and Wittenberg-Birnamwood—applied for a STEAM grant during the first application period for the program. Each district was awarded a \$1,000 STEAM grant, with the Bowler School District's grant divided between two programs.

Last year saw the first in-person Youth Leadership Congress held since 2019. The Congress is a cooperative leadership conference for teenagers to attend, sponsored by their local cooperatives. We had one participant attend the Congress, which was held at UW-Stout in Menomonie.

As we all know, the weather can be unpredictable and 2022 had its share of storms we had to deal with. The worst storm of the year hit June 15, and left a trail of damage, especially in the Bowler/ Stockbridge-Munsee area where an EF1 tornado was confirmed. In December our service area was hit with an ice storm that caused numerous power outages. For both storms CWEC received assistance from crews from other cooperatives through the Restoration of Power in an Emergency (ROPE) program. We thank those co-ops for the help, and will gladly reciprocate in the future.

CWEC completed several projects in 2022 with the goal to have less power outages in the future.

- The three-phase Wittenberg to Almon tie was upgraded with a combination of overhead and underground cable to allow future load growth and the ability to backfeed either the Wittenberg or Almon substations.
- The Dewey substation was the fifth completed substation of our eight substations to re-analyze our existing ground grid and provide additional improvements to protect our linemen and the public from touch or step potential in certain fault situations.
- The Robin Road overhead wire rebuild was the last phase of our Wittenberg to Almon tie. The project consisted of 1.25 miles of three-phase underground and overhead upgrades.
- Our unjacketed URD cable replacement project continued, with two miles of single-phase unjacketed underground cable and two miles of three-phase unjacketed underground cable being replaced.
- Also, as an ongoing effort to improve service reliability, our crews replaced five miles of old overhead lines with new conductor.

Completing those projects required extra planning, as we continued to experience supply-chain issues. Supply-chain issues have delayed the new metering system we were to begin installing in 2023. We will move forward with the project when all supplies are obtained.

Several businesses and dairy farmers worked with us to obtain rebates for energy efficiency projects they were completing. If you are looking to complete an energy efficiency project, contact our office at 715-677-2211 to see if there are any rebates available for your project.

To conclude, I want to focus again on our members and also the CWEC employees. Both are important in order for the co-op to run smoothly. To make sure that we are meeting expectations of our members, we conducted a Member Satisfaction Survey last year. We also conducted an Employee Culture Survey to make sure the needs of our employees are being met. The data received from these surveys has been reviewed and will be used when making future decisions.

We look forward to 2023, and will strive to continue to provide our members safe and reliable energy. I look forward to seeing you at our 85th annual meeting on Thursday, April 13 at 6 p.m.

Central Wisconsin Electric Cooperative • Rosholt, Wisconsin ANNUAL MEETING MINUTES • APRIL 19, 2022

President and CEO Mike Wade welcomed the membership to the 84th Annual Meeting of Central Wisconsin Electric Cooperative at 6:00 p.m., which was held at the Wittenberg-Birnamwood High School. All veterans were asked to stand and be recognized, the Pledge of Allegiance was recited, and Pastor Clifford Kessen gave the invocation.

Kevin Kurtzweil, VP of Operations, provided a safety message. Mr. Wade welcomed and introduced the directors and guests. Tom Smith, Board Chairman, called the 84th Annual Meeting of Central Wisconsin Electric Cooperative to order. Lee Lehrer, Secretary/Treasurer of the cooperative, kept the minutes thereof.

Mr. Lehrer announced that in accordance with the cooperative bylaws, we have sufficient members in attendance and registered to constitute a quorum. Motion was made and seconded to dispense with the reading of the Notice of Meeting as presented. Motion carried. Motion was then made and seconded to close the balloting. Motion carried. Motion was made and seconded to approve the April 27, 2021 Annual Meeting Minutes. Motion carried.

Kevin Kurtzweil, VP of Operations, gave his Operations Report, focusing on the outage recap numbers for 2021 and the causes. 2022 distribution inspections were also reviewed along with hazard recognition inspections. Photos were shared of the Tigerton Substation improvements. Replacements of HPS lights with LED lights at the Dewey and Almon Substations has been completed, and crews are currently working on the Wittenberg Substation. Other completed projects include the Iola Campground upgrade, Tigerton Mill upgrade, four miles of three-phase conversion from overhead to underground, three miles of #6 hard drawn wire replacement on Hwy. 153 and 91 new connects.

Brenda Mazemke, Manager of Member Relations, welcomed the members to the in-person meeting. Focusing on how to help members save money and energy, Ms. Mazemke informed the members about the energy saving tips on social media and in the *Wisconsin Energy Cooperative News* magazine each month. The Energy Conservation Rewards Program is a great place to get rewards for upgrading Energy Star-rated appliances, lighting and heating upgrades and home weatherization upgrades. Members were given a home energy efficiency kit for attending tonight's meeting. The Energy Conservation Reward Program has awarded over \$54,000 in energy conservation reward credits to our members.

Lila Shower, VP of Accounting and Finance, gave the Treasurer's Report, focusing on key statistics and highlights from 2021. Despite a slowdown in the early stages of the pandemic, 2021 ended with strong energy sales. Net margins came in at \$832,566. Our utility plant increased by \$2.7 million, which represents new line extensions, system upgrades and conversions and capital expenditures. Electric utilities are very capital intensive and we have \$35 million in long-term debt. Our remaining unretired capital credits are \$17.6 million, giving us an equity ratio of 34.41%. In 2021, the Board of Directors approved retiring \$454,542 in capital credits.

Chairman Smith gave the Board Chairman's Report. 2021 was a year filled with many successes. We continued to make investments that strengthened our electric distribution system through our maintenance programs and replacement of outdated poles and wires. We provided energy conservation rebates to our residential and commercial members that helps them make investments of their own in energy-saving appliances and equipment. We earned sufficient margins to satisfy our lender's requirements and we were able to return a portion of your investment in the cooperative to you in the form of retired capital credits. We are proud of the programs and services that we offer to our members and local communities. We had three directors retire in 2021. Tony Buss, Elaine Eckendorf and Leonard Oppor completed a combined total of 49 years of service.

Jim Halvorsen of the accounting firm CliftonLarsonAllen, gave the results of the 2022 Director Election as follows:

District 3	Allen Zander	288 votes
District 3	Rhonda Hollfelder	160 votes

Elected to three-year terms were Lee Lehrer – District 2 and Allen Zander – District 3.

Mike Wade, President and CEO gave the CEO report. He thanked the employees of Central Wisconsin Electric Cooperative for their dedication to our membership. West Riverside Energy Center is now up and running and we are starting to see the benefits of our investment in the form of credits passed on to our members. Special recognition was given to the Operations Department for their work during the July and December 2021 storm restoration.

Director Smith entertained any new business. None noted. A motion was made and seconded to adjourn the meeting at 6:52 p.m. Motion carried.

This concluded the 84th Annual Meeting of the membership of Central Wisconsin Electric Cooperative.

BYLAW MODIFICATION APPROVED BY BOARD OF DIRECTORS

t the Dec. 29, 2022 Central Wisconsin Electric Cooperative Board of Directors meeting, the Directors agreed to modify Article IV (Directors), Section 4 of the Cooperative's bylaws. The modifications need to be approved by the Cooperative's membership at the annual meeting on Thursday, April 13. The purpose of the modifications was to allow the election of an uncontested director position(s) to be conducted at the Annual Meeting by unanimous consent, voice vote, or similar means. Previously, the Cooperative was required to provide members mail-in or in-person ballots to cast. The revision will allow the Cooperative to save money due to not being required to mail ballots to members for uncontested director elections.

ARTICLE IV DIRECTORS

SECTION 4. Election and Tenure of Office. Directors of the Board are elected on a staggered basis so that no more than one director vacancy for any district is subject to election at any annual meeting. Each director shall be elected to serve a term of three (3) years. Directors representing districts may serve consecutive terms without limit. The at-large director may serve a limit of three (3) consecutive terms. If, for any reason except a tie vote, the members fail to elect a director, the vacancy shall be filled as provided in Section 7 of this Article.

All members may vote for the at-large director. Voting for any district director position shall be confined to members from that district. The candidate receiving the highest number of votes for each director vacancy shall be declared elected. In the event of a tie, the tie shall be resolved, and the result determined, by the flip of a coin.

In the event during a director election there is only one candidate for any director position(s), the election for the uncontested director position(s) may be conducted at the Annual Meeting by unanimous consent, voice vote, or similar means, at the discretion of the Chairman, without the need for the Cooperative to provide, or for the members to cast, mail-in or in-person ballots. Nominations from the floor of the annual meeting for a director position are not allowed pursuant to Article IV Section 3 of these Bylaws.

Following their election, directors shall take office at the meeting of the Board of Directors immediately following the annual meeting of the membership.

Not less than eighteen (18) days prior to any duly called membership meeting, there shall be printed and mailed to all members, ballots for <u>contested</u> director elections and for voting on any other agenda item authorized by the Board of Directors. Printed instructions and an explanation as to when and where ballot shall be returned will be included. Mail-in ballots shall be received by the Cooperative through the close of business on the last day prior to Annual Meeting. Ballots may also be cast at the Annual Meeting as authorized and directed by the Board of Directors.

Energy Efficiency Tip of the Month

This planting season, include energy efficiency in your landscaping plans. Adding shade trees around your home can reduce surrounding air temperatures as much as 6 degrees. To block heat from the sun, plant deciduous trees around the south side of your home. NEW ELECTRICITY RATES

In last month's issue of *Wisconsin Electric Cooperative News* we reported that the Central Wisconsin Electric Cooperative Board of Directors would be reviewing an electricity rate study and consider rate change recommendations at its February meeting.

During that meeting, the board discussed what rate adjustments were necessary. It is important to note that the board of directors takes its responsibility to set fair rates very seriously. After all, they are members of the cooperative and pay the same rates. After reviewing the rate study and recommended rate changes, the board approved a new schedule of rates that took effect March 1, 2023. The new rates will be reflected on the electric bill you receive in April. On average, electricity rates for residential members of the co-op will be increasing 3.4%. WHY A RATE CHANGE?

There are a variety of factors that played into the need for adjusting the electricity rates. Over the past year we have all seen the cost of living increase dramatically. Unfortunately, Central Wisconsin Electric Cooperative (CWEC) is not immune to those increases. The cost of energy we purchase from Alliant Energy to meet the energy needs of our members has increased over the past couple years. Much of the increase in the cost of energy is due to the increase in the cost of natural gas and coal.

In addition, almost all supplies that are needed to maintain our electrical system has increased in cost. Below are examples of some of the cost increases we have had to deal with:

Not only have the costs of items increased, but the lead times required to receive the items once they are ordered has increased dramatically. The four above items require a year and a half of lead time to receive them. In order to keep electricity flowing, we must maintain inventories that allow us to be prepared to respond to storms and other emergencies that can deplete our stock of material in a short amount of time. To accomplish this when supply-chain issues are occurring, we must keep more inventory, which requires an outlay of more funds.

FIRST RATE CHANGE SINCE 2016

As stated in last month's article, CWEC hasn't adjusted its rates since 2016. Since we are a not-for-profit electric utility, our rates are designed not to make a profit, but to simply cover the costs of providing that power.

It has always been the goal of CWEC to provide our members with the highest quality of service at the lowest possible cost. Over the past year or so, our investment in the West Riverside Energy Center in Beloit has helped us be able to insulate our membership from a rate change. Unfortunately, outside forces and costs have necessitated the need for a rate change.

Your electricity rates will continue to remain highly competitive, as all utilities are facing the same economic pressures and are also adjusting their rates.

For a rural cooperative like CWEC, it has fewer members per mile of line to share the fixed costs. CWEC serves almost six members per mile of line, while large urban utilities serve 30 or more consumers per mile of line. As you can see, this means costs are shared by fewer people for rural electric cooperatives.

WHAT CAN YOU DO?

Your electric bill is impacted by rates, but weather and your energy use also factor into how much your electric bill is each month. As energy prices rise, it's important to be as energy efficient as possible. The weather is out of our control, but we can help you identify ways to save energy.

You can use SmartHub, our online portal, to show daily usage, identify areas of savings, and view your bills. You can also call our office for information about home performance evaluations or other energy efficient upgrades to your home. There are also opportunities for energy assistance for members in need. Please call our office or visit our website for more information and where to apply.

BOARD MEETING SUMMARY

The January regular meeting of the Board of Directors of Central Wisconsin Electric Cooperative was held on January 26, 2023 at 8:01 a.m. The following is a summary of the meeting activities. The agenda, minutes of the December 29, 2022 meeting, new and terminated memberships, monthly safety and compliance report, and estate capital credit retirements were approved.

Action Items

- a. Monthly Financial Statements and Reports were approved. Finance Committee reviewed checks written and the board and CEO expenses.
- b. The board approved presenting the proposed Bylaw change regarding uncontested elections to the membership at the Annual Meeting April 13, 2023. The board also reviewed new Board Policy 110-Legal Representation and Use of Attorneys and requested Mike Wade to send it to the attorney for review.
- c. The board reviewed Board Policy 601-Identity Theft Detection and Prevention and had no recommended changes.
- d. The board approved Allard Meverden (Sub District 1B) and Ray Schulist (Sub District 3C) to fill the final vacancies on the Member Advisory Group.
- e. Kyle Kopczyk and Kahara Franze with Power System Engineering (PSE) gave a presentation to the board on their findings regarding load control to help reduce peak demand.
- f. Kevin Kurtzweil gave an informational presentation to the board on supply-chain issues and concerns we are facing with pricing and lead times of materials.

- g. Dennis Magee gave an informational presentation to the board on a current work order situation involving the construction of a lengthy line extension.
- h. The board approved the proposed 2023 donations from the Federated Youth Foundation Fund, along with those that qualify for the CoBank Sharing Success Program.

Operations – Kevin Kurtzweil reported crews are working on hazard recognition inspections. Crews will be working on oil circuit recloser maintenance at the Groenier and Rosholt substations. Using a sample member electric bill with solar, discussion was held regarding the calculations on the billing. Pool vehicle garage door remote was also reviewed and discussed. Zielies will be working on the Iola circuits.

Accounting and Finance – Lila Shower reviewed the CFC Investment-Select Notes from her submitted report. The year-end inventory reconciliation adjustment at the end of 2022 was \$2,549.76, very minimal compared to the amount of inventory that passes through our warehouse during the year.

Member Services – Brenda Mazemke reviewed the Annual Meeting ballot information, contested vs. non-contested race, where ballots should be returned to and who will announce the election results at the Annual Meeting. The board approved having ballots returned to the co-op if the race is uncontested, and if contested, ballots should be mailed to CliftonLarsonAllen. Attorney John Behling will give the election results at the Annual Meeting.

Administrative Services - Lori Patoka reviewed submitted report and had no updates.

President and CEO – Mike Wade, CEO, reported on his submitted report. Meeting adjourned at 2:10 p.m.

- 3. Members should give their name and township when speaking. Each member's comments will be limited to three minutes with any rebuttal limited to two minutes.
- 4. Members will be limited to one question. If time allows, members may ask additional questions.
- 5. Questions and comments from members will be in order only during the unfinished and new business sessions, and at the conclusion of the officer reports, if invited.
- 6. Any advisory resolution a member wishes to propose at the Annual Meeting must be submitted no later than 90 days before the meeting so that the Resolutions Committee may review the proposed resolution.
- 7. All voting will be by delegate voting card; there will be no voice voting.
- 8. No signs or handouts will be permitted within the building of the place of the meeting, except such handouts as required for the official conduct of the Annual Meeting. No handouts made available outside of the building will use the name of the Cooperative, its letterhead or logo to imply that the Cooperative supports or opposes any resolution.
- 9. No demonstrations shall be held within the building of the place of the meeting.
